SUBJECT: STATE FISCAL YEAR 2013/14 CHILD SUPPORT  
ADMINISTRATIVE INITIAL PLANNING  
ALLOCATION

The purpose of this letter is to provide local child support agencies (LCSAs) with their state fiscal year (SFY) 2013/14 initial planning allocation for administrative costs (Attachment I). The Department of Child Support Services (DCSS) is issuing this initial planning allocation prior to enactment of the SFY 2013/14 Budget Act in order to provide each LCSA with information to assist in their planning efforts. DCSS emphasizes that this is an initial planning allocation and is subject to change with the enactment of the annual Budget Act, effective July 1, 2013. The final allocation will be released after the enactment of the Budget Act for SFY 2013/14. Pursuant to the Office of Management and Budget Circular 133, LCSAs are notified that the federal award number for child support enforcement funds is 1304CA4004 and the Catalog of Federal Domestic Assistance number is 93.563.

The proposed funding for the child support program for SFY 2013/14, reflected in the Governor's Budget released in January 2013, restores the \$14.7M reduction in last year's budget. LCSAs are reminded to carefully monitor their expenditures and make appropriate adjustments throughout the year to remain within their total administrative allocation.

Attachment I identifies funding for ongoing expenses and displays the initial planning allocations with adjustments for agreed-upon shared services in a statewide format. LCSA expenditures will be controlled by the total Administrative Initial Planning Allocation.

**Revenue Stabilization**

The SFY 2013/14 Governor's Budget includes a Revenue Stabilization funding premise of \$18,735,000. Continuation of this premise is contingent upon approval by the California State Legislature as part of the SFY 2013/2014 budget.

The SFY 2013/14 electronic data processing funding allocations are not being released at this time.
